We do not speculate on the likelihood of success on the merits, as that is a decision that the district court should make in the first instance. Rather, we believe the district court should consider the injunction bond amount required in future proceedings. If a defendant is unable to satisfy the bond, then that defendant will be unable to comply with the district court's injunction and will be unable to proceed with the proceedings because the court will have previously determined that his rights have been violated. Accordingly, we vacate the district court's order denying Meese's motion to reconsider and remand for the district court to consider the appropriate amount of the injunction bond in its determination of the appropriateness of the preliminary injunction.
